DEFINITION

Responsible for providing general security program compliance enforcement specifically within the Airport Sterile, Secure and SIDA designated areas, at terminal drives, public and employee parking areas, vehicle access points, as well as terminal and adjacent ramp and airfield areas.

EXAMPLES OF IMPORTANT DUTIES AND RESPONSIBILITIES—Essential and *important duties and responsibilities may include, but are not limited to, the following:*

Essential Duties and Responsibilities:

Patrols assigned airport property in vehicle or on foot to support and enforce security, ground transportation services, and public safety regulations.

Issues airport rules violation citations as necessary and maintain records related to citations and prepares daily activity logs, vehicle and equipment repair requests, when required.

Monitors and directs vehicle and pedestrian traffic flow to and from the airport terminal building to reduce traffic accidents and incidents.

Reports suspicious activities and individuals, security and safety hazards.

Track and monitor passenger flow through security screening checkpoints and airline baggage processing.

Ensure concession tenant contract compliance and report non-compliance to supervisor.

Monitor tenant lease compliance, monitor vehicle-for-hire operations in compliance with JMAA ground transportation rules and regulations, coordinates enforcement of airport rules both land and airside

Other Essential Duties and Responsibilities:

Assists the general public by providing directions and responding to questions and inquiries and relaying on-site requests for assistance.

Inspecting assigned vehicles and equipment for maintenance or repairs.

May assist sworn officers with traffic control and response to emergencies.

Documents in writing incidents, accidents, or occurrences reporting essential information in accordance with department policy and procedures.

Coordinates providing customer service related to the welfare of passengers, airlines and tenants

Conduct initial investigations related to security and safety violations

Other Essential Duties and Responsibilities (continued):

Complies with department and division policies, plans, and procedures.

Performs other duties as required to ensure security and safety at the airport.
