This Addendum No. 1 ("Addendum") to the Request for Qualification ("RFQ") for services in connection with JMAA's Architectural Services for Public Restroom Renovation at JAN, JMAA Project No. 006-23 at JAN as of this, 15th day of February 2023.

1. Defined Terms. Capitalized terms used but not defined in the Addendum have the respective meanings given in the RFQ.
2. Could you forward the proposed project budget information to us?
Total Project Budget is \$986,000.00
3. In the Zoom meeting, a 31% DBE requirement was indicated for this project. The RFQ lists 0%. Could you please clarify the requirement.
DBE requirement is 31%
4. Will a full time CA representative be required to be on site during the duration of the project?
Construction Administration will be included in the architectural services scope of work.
5. Is there an anticipated construction time that this project is supposed to be completed in? Could you clarify the anticipated construction timeframe?
There is no anticipated construction time, but the project is expected to be phased in a way were there will be minimum interruption in bathroom availability.
6. Are there any LEED considerations, or other "Green" rating scales/requirements/standards that the design team will have to meet as part of the scope of this project?
LEED considerations are not required but design solutions should incorporate water efficient and electrical efficient fixtures.
