Dear Colleagues,

The Jackson Municipal Airport Authority (JMAA) is required to submit to the Federal Aviation Administration (FAA) overall, three-year goals for Airport Concession Disadvantaged Business Enterprise (ACDBE) participation in concessions at Jackson Medgar Wiley Evers International Airport (JAN) and the methodology for establishing the goals. FAA previously approved our Federal Fiscal Year (FFY) 2019 overall goals that were implemented for the period that ended September 30, 2019. The goals herein for non-car rental concessions and for car rental concessions are the proposed overall ACDBE participation goals for the remaining two FFYs 2020 and 2021, in this three-year period.

Before submitting this information to FAA, JMAA is conducting a webinar to seek public comment on its proposed overall ACDBE participation goals of 36.25% for non-car rental concessions and 0.93% for car rental concessions for federal fiscal years 2020 through 2021. The webinar will be held:


